This statement relates to Shares (as defined herein) held for the accounts of (i) Quantum Strategic Partners Ltd., an exempted limited company organized and existing under the laws of the Cayman Islands ("Quantum Strategic Partners"), and (ii) QSP Athena LP ("QSP Athena"), a Delaware limited partnership. SFM LLC serves as principal investment manager to Quantum Strategic Partners. As such, SFM LLC has been granted investment discretion over portfolio investments, including the Shares, held for the account of Quantum Strategic Partners. SFM LLC serves as principal investment manager to QSP Athena. As such, SFM LLC has been granted investment discretion over portfolio investments, including the Shares held for the account of QSP Athena, but does not have the power to vote (or direct the vote) of such Shares. SFM LLC must either (i) vote such Shares in the same manner as other shareholders of the Issuer vote their Shares or (ii) seek voting instructions from the limited partner(s) of QSP Athena and vote in accordance with such instructions. George Soros serves as Chairman of SFM LLC and Robert Soros serves as President and Deputy Chairman of SFM LLC.
