#### NOTICE OF CHANGE TO ANNUAL MEETING OF SHAREHOLDERS

NEW YORK — May 13, 2020 — Owl Rock Capital Corporation (NYSE: ORCC, or the "Company") announced today that, due to the novel strain of coronavirus known as "COVID-19" and related health and travel concerns, it has determined not to hold an in-person 2020 Annual Meeting of Shareholders (the "Meeting").
